This project is to build a new shoreline deck, docks, and boat shelter.

This project is to build a home addition, dock addition, and boat shelter.

Mr. Kinnick made a motion to approve and recommend approval of application 20-023 pending a 14' maximum railing height on the party deck and all required permits by Brown County. Mr. Deiner seconded. Motion passed unanimously.

This project is to build new docks, boat shelter, and covered seating area.

Mr. Cameron made a motion for a variance as submitted or to reduce the dock square footage to at least the maximum allowed square footage. If square footage is reduced, a recommendation for approval was made for application 20-024. Mr. Kinnick seconded. Motion passed unanimously.

This project is to add 165 SqFt of dock and build a 4' X 4' jump platform.

Mr. Kinnick made a motion to recommend approval of application 20-025 pending a survey and at least a 12' depth of water below jump platform. Mr. Cameron seconded. Motion passed unanimously.
