In 2020, there were 136 permit applications received, 135 permits were issued, 1 application was denied, 0 applications are pending approval, 0 withdrawn, and there are 2 active stop work orders. There were 309 projects involved in the 135 permit applications. This is a 37% increase in the number of 2020 projects (226). The difference in the count of projects and permits results from permits which include more than one project, for example a dock and a deck on one permit. 135 permits issued in 2020 is a 53% increase from 2019 (89 permits issued).

Completed Projects:

- Trail 6 constructed between CSCD Office and Clubhouse
- Pickleball Courts painted on Centerlake Park Basketball Court
- All buoys GPS marked and added to GIS
- Coffer dam work completed on Antelope, Grizzly, and Groundhog
- Core samples taken from Cordry Dam Spillway
- GPS all CSCD Hiking Trails and added to public GIS map
- Replaced decking at old Beach House



2020 Projects

- Cordry Dam Spillway engineering and design
- Create pollinator habitat across from beach
- Coffer Dam restoration possible on Cougar Drive & Bass CT/ Centerlake as funds are available
- Improve rest room access at Centerlake Park
- Improve communication and measures to prevent Zebra Mussel infestations
- Coordinating with CSLOA on a "Welcome-Packet" for new Freeholders that will include a Parks & Rec brochure and other Ecology-related media

Roads Commission Annual Review:

2020 Projects Completed:

- Patch and overlay on Sweetwater Drive (Duck to Eagle, patch-only), both backgates, Alder, Elm, Ebony, Nuthatch, and Eagle Drive (patch-only)
- New culverts installed on Pheasant Drive and Lion Drive
- Erosion control work completed on Robin Court and Grizzly Drive
- Added stone shoulders throughout main roads

2021 Planned Projects:

- Install catch-basins on Duck Ct and Sweetwater Dr
- Ditching along Sweetwater Drive
- Extensive work on Elk Drive including ditching and erosion control textiles
- Pavement repairs on Cougar, Groundhog, Gopher, and Grizzly



Other:

- 281 work orders completed in 2020 with 634 labor hours expended on Streets. Total cost on Streets in 2020 was \$371,780.
- 13 Winter Weather Events in 2020 with 74 labor hours expended
- Wagler Brothers spread gravel on streets 42 times in 2020

WATER Commission Annual Review:

2020 Highlights:

- 100% Compliance with IDEM
- 24.48% rate increase due to 36% rate increase from Prince's Lakes
- Completed the water utility's Asset Management Plan
- The lowest real water loss percent in 5 years in October 2020 (26%)
- Every meter, hydrant, and valve are now GPS and included in our GIS map
- Line locates nearly tripled due to beginning stages of Fiber Optic infrastructure by REMC

2020 Cordry Sweetwater Security Commission Highlights

- Improved enforcement of unauthorized watercraft being removed from the lakes
- Refurbished the motors and drivetrains of two existing patrol vehicles
- Reviewed and began process of restructuring the Shelter House rental/use
- Approved paddle board safety guidelines of using a light after dark as well as requiring a life jacket at all times.
- Placed an additional 5 illuminated buoys around the lakes
- Speed reminder signs moved periodically around the roads within the lake area
