RESOLUTION NO.2019-03

RESOLUTION AMENDING RESOLUTION NO.2014-03 REGULATING THE TAKING OF FISH FROM CORDRY AND SWEETWATER LAKES AND PROVIDING FOR PENALTIES FOR VIOLATION THEREOF

WHEREAS, the Cordry-Sweetwater Conservancy District ("CSCD") is an Indiana Conservancy District organized and operated pursuant to I.C.14-33; and,

WHEREAS, the Board of Directors of CSCD previously adopted Resolution No. 2014-03, last amended by Resolution No. 2018-04 on March 20, 2018; and,

WHEREAS, Resolution No. 2018-04 amended Resolution No. 2014-03 regulating the taking of certain fish species from Cordry and Sweetwater Lakes and providing penalties for violation thereof; and,

WHEREAS, the Board of Directors of CSCD has received additional information from the CSCD Ecology Commission and a request from the Ecology Commission to further amend Resolution No. 2014-03; and,

WHEREAS, the Ecology Commission's recommendation is that the Fishing Rules of CSCD be amended to allow the taking and keeping of no more than ten (10) bass per angler, per day, from Cordry Lake and no more than ten (10) bass per angler, per day, from Sweetwater Lake, provided that no fish measuring between thirteen inches (13") and sixteen inches (16") may be kept. Of the ten (10) bass allowed to be kept from each Lake, no more than two (2) may be smallmouth bass and no more than one (1) smallmouth bass may exceed sixteen inches (16") in length; and,

WHEREAS, it appears to the Board of Directors of CSCD that the Ecology Commission possesses unique expertise concerning the management of the fisheries of Cordry and Sweetwater Lakes and that the authority to regulate the taking and keeping of fish from the waters of Cordry and Sweetwater Lakes should be delegated to the Ecology Commission.

NOW BE IT THEREFORE RESOLVED by the Board of Directors of the Cordry-Sweetwater Conservancy District that the Fishing Rules be amended to allow the taking and keeping of no more than ten (10)

bass per angler, per day, from Cordry Lake and no more than ten (10) bass per angler, per day, from Sweetwater Lake, provided that no fish measuring between thirteen inches (13") and sixteen inches (16") may be kept. Of the ten (10) bass allowed to be kept from each Lake, no more than two (2) may be smallmouth bass and no more than one (1) smallmouth bass may exceed sixteen inches (16") in length.

BE IT FURTHER RESOLVED that from and after May 1, 2019, the CSCD Ecology Commission is delegated the authority to establish bag and size limits for fish taken from the waters of Cordry and Sweetwater Lakes provided that said authority may only be exercised by the Ecology Commission if consented to by the CSCD Board Member appointed to the Ecology Commission. In the event the Ecology Commission amends the Fishing Rules, it shall cause a copy of the amendment to be promptly delivered to the Conservancy District Manager. No amendment by the Ecology Commission shall become effective until notice of the amendment is delivered to the Conservancy District Manager.

BE IT FURTHER RESOLVED that all parts of Resolutions No. 2014-03 and No. 2018-04 and the Fishing Rules created pursuant to said Resolutions not specifically amended by this Resolution shall remain in full force and effect.

BE IT FURTHER RESOLVED that this Resolution shall be in full force and effect from and after its passage.
