- Construction of the new Ellettsville Town Hall.



HISTORY

Early property owners were certainly pioneers! Jesse and Ruth Ann Gillentine purchased their lot in 1953 for \$1,000. They put the baby in a playpen and physically cleared their prize lot themselves. They installed a seawall of cement "I" block before the lake was filled. (property owners know exactly where the water level would reach) That seawall is still in place and in excellent repair! Later in 1966 they built their cabin on the lake. They had a basement dug and place a kit, Pan Adobe cedar cabin on top of the basement for approximate cost of \$10,000. After her husband Jesse retired from Indiana Bell Telephone, they moved to the lake as a permanent resident in 1982. Jesse Gillentine served on the Security Commission for 29 years. Jesse passed in 2009. Ruth Ann continues to live here keeping tabs on her son who now lives next door.

I hope everyone had a great summer with their family and friends enjoying this beautiful area. As you are planning your fall and spring construction, now would be a good time to get a survey scheduled if your project would require one. It has been quite a busy year so far, as of this writing, I have received 91 building applications.

I would like to highlight a rule regarding the free-standing boat lifts. They do require a permit application and approval. They also have the same setback requirements as docks. If you are planning to install a lift, I would be glad to explain the process and answer any questions you may have.

Please keep in mind that road restrictions will go into effect at midnight on December 15th. The restriction limits vehicles and their load at 20,000 gross vehicle weight. As always, if you have a project in mind, I'd gladly meet with you to discuss it prior to turning in the building application.

Fall Leaves Bring Important Maintenance Responsibilities

he beauty of fall in Brown County is unsurpassed in the State of Indiana. But with the turning of the leaves comes the inevitable falling of the leaves. Those fallen leaves can cause major

maintenance headaches in areas like the CSCD when it comes to proper drainage and erosion control.

Roadside ditches in the Conservancy are a bit of a gray area. Some

ditches are on CSCD road property while other's are on private property.

The CSCD has adopted a generally accepted maintenance plan for ditches that includes periodic clean-outs of leaves and debris. However, it is not feasible in the fall for the Grounds Department to clean the ditches out every hour or every day while leaves are falling. We need lot owners to do their part in insuring that ditches and culverts near their property remain clean.

The District is not responsible for damage on lot owner property caused by flooding, erosion, or other acts of God even if a ditch or culvert gets clogged.

One major problem we see is residents blowing leaves from their yards into drainage ditch-

es. That is now against CSCD rules and can lead to losing lake privileges as it can directly cause harm to the lakes due to erosion.

The CSCD has a dedicated area for fallen leaves locat-

ed between the Fire Station and Cordry Dam on Centerlake Road.

Let's all work together to maintain both the public AND private properties at these beautiful lakes!

Dam Reconstruction on Cordry

A hot topic in the district, that will be happening over the next few years, will be Dam reconstruction on Cordry Lake. This year the Cordry Dam has now been classified by the Indiana Department of Natural Resources (IDNR) as a significant hazard structure. Dams classified as significant hazard are required to safely pass the rainfall runoff from the 50% Probable Maximum Precipitation (PMP) event without overtopping. Should the dam be classified as high hazard, the spillway capacity requirement would increase to 100% PMP. A more detailed spillway capacity analysis would be required, the existing spillway system configuration appears to be capable of passing at or near 100% PMP. Regardless of the dam's existing spillway capacity, and in accordance with the recommendations of the engineers August 2020 structural inspection summary, it is recommended that the district complete a preliminary engineering study. This is to evaluate spillway replacement options that will safely pass the rainfall runoff from the 100% PMP storm event without overtopping the dam. The resulting spillway system would not significantly change the existing flow conditions and would meet IDNR requirements for high hazard structures should the dam be reclassified. It is anticipated that a preliminary study would consider up to three spillway replacement options, replacement costs are yet to be determined. The engineers have been collecting and processing data all year long, they are hoping to have this phase completed by the end of September 2021. The current timeline of the dam reconstruction points towards the Design/Permitting phase to be completed by the end of 2022, just in time to break ground on the construction in 2023. Next year, the CSCD Board of Directors have budgeted to spend \$300,000 from the Rainy-Day Fund to cover the Design/Permitting Phase of the dam reconstruction. There is currently no timeline for the overall completion on the reconstruction project. Stayed tuned for more updates!



. Financial Advisory Committee Update and Survey Results

The Financial Advisory Committee (FAC) has been working since the beginning of 2021 to fulfil its mission to explore ways to fund the approved budget and eventually decouple from the reliance upon value-based assessments for the collection of CSCD revenues. We are seeking a long-term solution that will be phased in over time. Our work includes determining how each activity should be funded using ad valorem assessments, equal assessments (ditch fees) and user fees. As part of the process, FAC decided it would be helpful to understand the community's knowledge about the services provided by and to the CSCD and the funding source for those items. The committee was also interested in what Freeholders found was most important about life in the community. So, a survey was developed, and responses solicited from Freeholders via the many community Facebook pages and with the help of the CSCD text / e-mail system. Of 1,669 taxable lots, 538 survey responses were received. As requested by responders to the survey, the FAC is sharing the results of the survey.

The results reveal the following ranking of benefits of the community:

Lakes (clear water, swimming, ramps and dams) - 58.7% felt is most important

Boating (private access, marina, safety patrol) – 30.5% felt is 2nd is most important

24/7 Security (CSCD employed deputies on patrol) – 23.2% felt is 3rd most important

Roads (snow removal, maintenance, striping, gravel – 23% felt is 4th most important



The second part of the survey asked Freeholders to identify who they believed provided the funding for community benefits such as sheriff patrols, fire department services, and clubhouse. The funding options were: CSCD, CSLOA (Cordry/Sweetwater Lot Owners' Association), Brown County and "Other." Most respondents had a basic understanding of who funds which benefit. The survey revealed that more outreach is needed to be sure that Freeholders understand that the fire department is not funded by the CSCD but primarily by fundraisers, donations and memberships or "Other" and that the Library is actually a function of the Brown County Public Library system in cooperation with the CSLOA, who owns the building. Also, the recycling bins are a function of Brown County Solid Waste District and are provided near the Conservancy office for our convenience.

Many thanks to those who completed the survey. The information is very helpful and will aid FAC in its quest to identify and ultimately recommend alternate funding solutions to the CSCD Board. Stay tuned for more information in the coming weeks and months.

Safety Spotlight

All the Deputies here at The Lakes are Brown County Deputies that work for and paid by CSCD. There are times the Other Deputies working the County and other agencies will call upon us for assistance, as we call on them for assistance. We work as one team. All the Officers that work the lakes go above and beyond to assist the freeholders. Crime does not stop at all three entrances here at the Lakes. WE DO HAVE CRIME. However, by all Officers actively patrolling has cut crime down. I have asked all the Officers to continue patrolling and enforcing all the laws to let the criminals know we will NOT tolerate crime. The Law enforcement here at the lakes are proactive. For example, myself and my officers' knowledge of what most freeholders drive helps us know what vehicles belong at most of the homes. We also utilize the boats to patrol the lakes to assure the safety of the homes on the waterfront, as well as keep the waters safe for all who use the lakes. My team has a great response time, 5-10 minute here at the lakes. If an Officer had to respond from the Sheriff's office, it could take up to 30 to 50 minutes. It could take longer if they are busy on other calls. On some calls, every minute counts.

We respond to all medic and fire calls in the lake area. We are all trained in first aid, CPR, and with the AED.

In my 40 years as a Law Enforcement Officer, along with firefighting, I have attended several training classes. I am trained for crisis intervention and hostage negotiation, Swift water rescue and Ice rescue.

Please remember as we all enjoy walking around the lakes and riding our bikes, please read the Indiana State Laws for bike riding and pedestrian traffic.
