18-079 - 7003 Eagle Dr. - Stoops

This project is to build a 480 SqFt. dock with two slips and a 24' x 26' boat shelter.

Mr. Cameron made a motion to recommend approval of 18-079 pending lot length and that the structure is built within the rules. Mr. Ellis seconded. Motion passed unanimously.

18-080 - 6464 Buffalo Dr. - Stewart

This project is to build a 480 SqFt. dock with two slips and a 34.5' x 35.5' boat shelter, and 40 SqFt. dock storage.

Mr. Patterson made a motion to recommend approval of 18-080. Mr. Hetherington seconded. Motion passed unanimously.

18-081 - 7638 Heather Dr. - Sears

This project is to build a 480 SqFt. dock with one slip and a 15' x 24' boat shelter.

Mr. Patterson made a motion to table application 18-081 till the November 2018 BCC meeting. The options would be to change the design of the lake structure, get a permanent recorded easement from the neighboring property, get a cove survey & meet a 7.5' setback from the centerline of the cove. This project is to build a 17' X 18' deck, a 280 SqFt. dock with one slip, and a 12' x 20' boat shelter. Mr. Patterson made a motion to recommend approval of 18-082. There was discussion that it would be beneficial to get a survey to avoid shallow water near the shoreline due to erosion. Mr. Ellis seconded. Motion passed unanimously.
