

**RESOLUTION NO. 2025 - 8**

**RESOLUTION AMENDING RESOLUTION NO. 2019-03,  
REGULATING THE TAKING OF FISH FROM CORDRY AND SWEETWATER  
LAKES AND PROVIDING FOR PENALTIES FOR VIOLATION THEREOF**

WHEREAS, the Cordry-Sweetwater Conservancy District ("CSCD") is an Indiana Conservancy District organized and operating pursuant to I.C.14-33; and,

WHEREAS, I.C. 14-33-5-20(1) provides that the Board of Directors of CSCD exercise general supervision of and make regulations for the administration of the affairs of CSCD; and,

WHEREAS, I.C. 14-33-5-20(10) authorizes the Board of Directors of CSCD to establish advisory committees; however, those committees are only authorized to act in an advisory manner and may not adopt or enforce rules and regulations for the administration of the affairs of CSCD; and,

WHEREAS, Resolution No. 2019-03 purports to place rule-making and enforcement authority concerning the taking of fish from Cordry and Sweetwater Lakes with the Ecology Commission; and,

WHEREAS, it appears to the Board of Directors of CSCD that Resolution No. 2019-03 should be amended to remove the authority to adopt and enforce rules and regulations concerning the taking of fish from Cordry and Sweetwater Lakes from the Ecology Commission and to place that authority with the Board of Directors of CSCD.

**NOW BE IT THEREFORE RESOLVED** by the Board of Directors of the Cordry-Sweetwater Conservancy District that:


1. No more than ten (10) bass per angler, per day, may be taken from Cordry or Sweetwater Lake provided that no bass measuring between thirteen inches (13") and sixteen inches (16") may be kept. Of the ten (10) bass allowed to be kept from each lake, no more than two (2) may be small mouth bass and no more than one (1) small mouth bass may exceed sixteen inches (16") in length.
2. Resolution No. 2019-03 is repealed in its entirety. All parts of Resolution No. 2014-03 and Resolution No. 2018-04 and the fishing rules created to those Resolutions not specifically amended by this Resolution shall remain in full force and effect.
3. This Resolution shall be in full force and effect from and after its passage.




